Sweet Potato Casserole

This easy dish is a hit with children. Ask some of them to help mash the potatoes or spoon on the cranberries!

2-15 ounce cans of sweet potatoes, drained
1-8 ounce can of crushed pineapple, drained
2 tablespoons butter, melted
¼ teaspoon salt
1/8 teaspoon ground nutmeg
Dash of black pepper
Large egg
1-16 ounce can whole –berry cranberry sauce, divided.
Cooking spray.

Preaheat oven to 350°. Combine sweet potatoes and pineapple in a large bowl; mash with a potato masher. Sitre in butter, salt, nutmeg, pepper and egg. Swirl in 1 cup cranberry sauce. Spray a 1 quart casserole dish with cooking spray and pour in the sweet potato mixture. Top the casserole with the remaining cranberry sauce. Bake at 350° for 40 minutes. Serve to children a minimum of ¼-1/2 cup servings according to the meal/snack and minimum requirements of a fruit/vegetable for the age of the child.
